BYLAW NO. 1017

A BYLAW TO ESTABLISH A LOCAL SERVICE WITHIN THE REGIONAL DISTRICT TO PROVIDE CAPITAL FUNDING FOR THE CONSTRUCTION OF A NEW PUBLIC LIBRARY BUILDING WITHIN THE TOWN OF GIBSONS

WHEREAS a regional district may, by bylaw, establish a local service under the provisions of Part 24, Section 788(1)(e) of the Municipal Act to provide capital funding for the construction of a new Public Library Building within the Town of Gibsons;

AND WHEREAS the Regional Board of the Sunshine Coast Regional District wishes to establish a local service for the purpose of providing capital funding for the construction of a new PUBLIC LIBRARY BUILDING within the Town of Gibsons with Electoral Areas E, F, and the Town of Gibsons as participating areas;

AND WHEREAS the Regional Board has submitted the proposal to establish the local service to the electors of Electoral Areas E, and F;

AND WHEREAS pursuant to Section 796(2) of the Act, the Regional Board has obtained the assent of the electoral area electors;

AND WHEREAS the Council of the Town of Gibsons has given consent by resolution;

NOW THEREFORE the Regional Board of the Sunshine Coast Regional District, in open meeting assembled, enacts as follows:

1. The Regional District hereby establishes, within Electoral Areas E, F, and the Town of Gibsons a local service for the purpose of providing capital funding for the construction of a new PUBLIC LIBRARY BUILDING within the Town of Gibsons, to be known as "GIBSONS and DISTRICT PUBLIC LIBRARY BUILDING LOCAL SERVICE".
2. The costs of providing the service established under Section 1. shall be recovered by requisition of money to be collected by a property value tax on land and improvements, assessed for Regional Hospital District purposes, in accordance with Section 804(1)(a) of the Municipal Act.
3. Participating members in the "GIBSONS and DISTRICT PUBLIC LIBRARY BUILDING LOCAL SERVICE" shall be Electoral Areas E, F and the Town of Gibsons.

4. The Maximum amount that may be requisitioned annually for the Service under Section 804(1)(a) shall not exceed Two Hundred Fifty Thousand Dollars (\$250,000).
5. The costs of providing the Service shall be apportioned among the participating municipal members on the basis of the converted value of land and improvements, as assessed for Regional Hospital District purposes, in those areas.
6. This Bylaw may be cited for all purposes as "GIBSONS and DISTRICT PUBLIC LIBRARY BUILDING LOCAL SERVICE ESTABLISHMENT BYLAW NO. 1017, 1993."

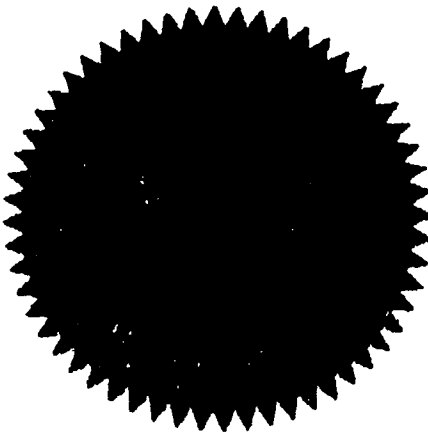
